ORDINANCE NO. 656

AN ORDINANCE AMENDING CHAPTER 3, CITY ADMINISTRATION, MUNICIPAL CODE, LEROY, ILLINOIS, 1975 (as amended), SECTION 3.11 SUB-SECTION 4. TRAFFIC, SUB-SUB-SECTION C. ILLEGAL PARKING

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents to reduce the ordinance violation charge provided under Section 3.11 Settlement of Certain Ordinance Violation Charges, as to Sub-section 4. Traffic, sub-sub-section C. Illegal Parking, violations of Chapter 41, Section 41.07, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), and

WHEREAS, the Mayor and City Council of the City of LeRoy find that a reduction from the current settlement charge of \$50.00 to a charge of \$15.00 is appropriate,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Chapter 3, Section 3.11, sub-section 4. Traffic, sub-sub-section C. Illegal Parking, is hereby amended by deletion of the reference in the "Section" column to section 41.07.

Section 2. Chapter 3, Section 3.11, sub-section 4. Traffic, sub-sub-section C. Illegal Parking, is hereby amended by addition of new sub-sub-section C. 5 Illegal Parking in "No Parking" Zones, said sub-sub-section to be in words and figures as follows:

C.5 Illegal Parking in "No Parking" Zones	41	41.07	15.00

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
