ORDINANCE NO. 13-08-02-50

**AN ORDINANCE AMENDING
TITLE III (BUSINESS AND LICENSE REGULATIONS)
CHAPTER 3 (LIQUOR CONTROL)
SECTION 3-3-19 (DAYS AND HOURS OF SALES) And 3-3-11 (CERTIFICATION OF
LICENSES; FEES; RESTRICTIONS ON LICENSES)**

WHEREAS, the City of LeRoy, Illinois has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and to protect the public health, safety, and welfare of its citizens; and

WHEREAS, the City also has the authority to regulate the Days and Hours of Sales of sale of alcoholic beverages within its corporate limits; and

WHEREAS, Title III, Chapter 3 of the City Code of Ordinances sets forth the City's Liquor Control regulations; and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. Title 3, Business and License Regulations, of the Municipal Code of Le Roy, Illinois 2003, Chapter 3, Liquor Control, Section 19, Days and Hours of Sales; Emergency Closures: (3-3-19-A), be repealed.

SECTION 2. Title 3, Business and License Regulations, of the Municipal Code of Le Roy, Illinois 2003, Chapter 3, Liquor Control, Section 19, Days and Hours of Sales; Emergency Closures: (3-3-19-A), be added:

- A. Days and Hours of Sales: It shall be unlawful to sell or offer for sale at retail any alcoholic liquor in the City between the hours of one o'clock (1:00) A.M. and seven o'clock (7:00) A.M. on any day. All holders of liquor licenses, with the exception of restaurants, may sell both served and packaged goods from the hours of 7:00 A.M. until 11:00 P.M. on Sundays. In

addition, said holders may sell same from the hours of seven o'clock (7::00) A.M. until one o'clock (1:00) A.M. Monday through Saturday.

In the case of restaurants, such establishments may be kept open during such hours, but no alcoholic liquor may be sold or consumed by the public during such hours, unless such restaurant is the holder of a class D license, in which case, the hours for sales of liquor on Sunday shall be as set forth in connection with the designation for class D license privileges under section 3-3-11 of this chapter, or unless such restaurant is the holder of a class A-S license or a class B-S license, in which case, the hours for sales of liquor on Sundays shall be as set forth in this subsection.

SECTION 3. Title 3, Business and License Regulations, of the Municipal Code of Le Roy, Illinois 2003, Chapter 3, Liquor Control, Section 11, Classification of Licenses; Restriction on Licenses; Fees; Subsection D, Class D Licenses (3-3-11-D-Item 5) be repealed.

SECTION 4. Title 3, Business and License Regulations, of the Municipal Code of Le Roy, Illinois 2003, Chapter 3, Liquor Control, Section 11, Classification of Licenses; Restriction on Licenses; Fees; Subsection D, Class D Licenses (3-3-11-D-Item 5) be added:

D. Class D Licenses:

5. Notwithstanding any other provision of this chapter, nor any other provision in any other city ordinance, the holder of a class D license may sell alcoholic liquor within the terms of said license between the hours of twelve o'clock (12:00) P.M. and eleven o'clock (11:00) P.M. on Sundays. Class D liquor license holders, in addition to the foregoing, may sell alcoholic liquor from twelve o'clock (12:00) P.M. on December 31 until one o'clock A.M. on January 1.


