

ORDINANCE NO. 14-01-02-80

**AN ORDINANCE PROVIDING FOR AND APPROVING THE DISPOSAL OF
PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY,
ILLINOIS**

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m., on January 20, 2014, did make and aforesaid determination;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

Section 1. The 2002 Dodge Intrepid SE with vehicle identification number 2B3HD46V82H258848 and the, 1996 Eagle Talon with identification number 4E3AK24Y3TE000133 are hereby declared surplus with the intent of having both vehicles destroyed due to their poor condition.

Section 2. That such disposal is hereby ratified.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.






