

## ORDINANCE # 13-12-01-10

### AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES FOR THE FISCAL YEAR COMMENCING ON THE FIRST DAY OF MAY, 2014 AND ENDING ON THE THIRTIETH DAY OF APRIL, 2015 FOR THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS.

BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, Illinois as follows:

SECTION ONE: A property tax for the following sums of money, or as much thereof as may be authorized by law shall be levied to defray all expenses and liabilities of the City of Le Roy for the purposes specified against all taxable property in the City of Le Roy, Illinois, for the fiscal year commencing on the first day of May, 2014 and ending on the thirtieth day of April, 2015.

At the time of the above referenced bond issue by the City, a levy was filed for this issue with the County Clerk. Currently a 2013 levy of \$289,502.50 is on file with the County Clerk for collection in 2014.

For an Alternate Bond issue such as yours, this levy needs to be abated in its entirety prior to the County Clerk's deadline for such abatement. The City Council will need to initiate and file the appropriate abatement resolution with the County Clerk prior to this date. We recommend that you obtain from the County Clerk some form of receipt indicating the levy has been abated to maintain with the records regarding this issue.


