

LEVY ORDINANCE 83

TAX LEVY ORDINANCE OF THE CITY OF LE ROY, ILLINOIS FOR THE FISCAL
YEAR ENDING APRIL 30, 1979

WHEREAS, the City Council of the City of LeRoy, McLean County, Illinois have heretofore regularly and legally passed the Annual Appropriation Ordinance for said City of LeRoy for the fiscal year ending April 30, 1979, and which Annual Appropriation Ordinance was legally and duly published in the LeRoy Journal, as provided by law, and more than ten (10) days prior hereto, and which Appropriation Ordinance is by reference made a part hereof

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LE ROY, McLean County, Illinois in regular session this 21st day of August, A. 
