**ORDINANCE 12-09-02-60**

**AN ORDINANCE AMENDING TITLE ONE OF THE CITY OF LE ROY MUNICIPAL CODE CONCERNING THE OFFICES OF CITY CLERK AND CITY TREASURER**

**WHEREAS**, pursuant to 65 ILCS 5/3.1-25-90, a municipality of fewer than 5,000 inhabitants can choose to have the city clerk appointed instead of elected if approved by a 2/3 vote of the corporate authorities; and

**WHEREAS**, pursuant to 65 ILCS 5/3.1-20-5, a municipality of fewer than 10,000 inhabitants can choose to have the treasurer appointed instead of elected by ordinance of the corporate authorities; and

**WHEREAS**, the City of LeRoy has less than 5,000 inhabitants; and

**WHEREAS**, the Mayor and City Council of the City of LeRoy have determined that it is in the best interests of the City and its residents to amend the LeRoy City Code to provide that the offices of city clerk and city treasurer shall be appointed offices rather than elected offices, as set forth in this Ordinance;

**BE IT ORDAINED** by the Mayor and City Council of the City of LeRoy, Illinois, as follows:

**Section 1:** The foregoing recitals are incorporated as substantive portions hereof as though fully set forth herein.

**Section 2:** Section 1-8-1, entitled "City Officers Enumerated" of the LeRoy City Code is hereby amended as follows:

**1-8-1: CITY OFFICERS ENUMERATED:**

- A. **Offices Created By City:** Various city offices have been created prior to the effective date hereof. The following is a list of the city offices now in existence:

**Section 3:** Section 1-8-5, entitled "Salaries" of the LeRoy City Code is hereby amended as follows:

**1-8-5: SALARIES:**

A. Schedule: The effective date of the salary and compensation schedules, as well as the other provisions regarding compensation and benefits shall be May 1, 2011.

2. Salary And Pay Schedule For Appointed Officers And Employees: The salary and pay schedule for appointed officers and employees is as provided by ordinance of the city council.

**Section 4:** The salary and pay schedule for appointed officers and employers is hereby amended to add the following salaries to the schedule:

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.






