AN ORDINANCE MODIFYING THE PAY SCHEDULE FOR ELECTED OFFICIALS, OFFICERS, AND EMPLOYEES OF THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS

BE IT ORDAINED, by the City Council of the City of Le Roy, Mc Lean County, Illinois:

WHEREAS, the Mayor and City Council of the City of Le Roy, Mc Lean County, Illinois, an Illinois Municipal Corporation, have determined that it is appropriate to change the salaries and pay scales for various employees and officers.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

SECTION 1.

SECTION 3. The effective date of the Salary and Compensation Schedules as set forth herein, as well as the other provisions regarding compensation and benefits as set forth after this section, shall be September 17, 2012.

SECTION 4. The City Council delegates authority to the City Administrator from time to time, to raise the pay of any employee up to the maximum amount indicated under the salary and pay schedule for appointed officers and employees as set forth previously in this ordinances up to a maximum of 8% annually. Reduction in pay or other compensation may only be made by the City Council.

SECTION 5. All new employees, not including police officers, shall remain on probation for a period of ninety (90) days, said probation period being for the purpose of determining the individual's ability to perform the duties of his or her job. All new police officers shall remain on probation for a period of twelve (12) months, said probation period being for the purpose of determining the individual's ability to perform the duties of his or her job. Additional probation time may be added at the discretion of the City Administrator as deemed necessary after a performance evaluation near or at the end of the probation period.

SECTION 6. The City delegates authority to the City Administrator to raise the rate of any employee up to \$2.00 per hour for the purpose of increasing the responsibility of said employee for a specific job and duration.

SECTION 7. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
