Any employee assigned to acting position of Supervisor or higher position shall be paid the salary of that position after a period of one week with the exception of Acting City Marshal who shall receive an hourly rate equal to City Marshal salary and over-time rate after 40 hours per week from starting date.

Court time duty of Pólice Officers will be considered straight time, no overtime considered.

All new full-time employees, with the exception of police officers, will be paid full pay from hire date and remain on probation for a period of 90 days to determine ability to perform work satisfactorily. All new full-time police officers will be paid full pay from hire date for a period of 120 days probational period with additional time of probation added at the discretion of the City Council as deemed necessary with performance evaluated annually or as required.

BE IT FURTHER ORDAINED that all prior ordinances or portions thereof of this City in conflict herewith be and they are hereby repealed.
