ORDINANCE NO. 641

AN ORDINANCE AMENDING ORDINANCE NO. 589 - SALARY SCHEDULE ORDINANCE

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is appropriate to amend Ordinance No.

589 - Salary Schedule Ordinance, adopted by the City Council on April 17, 1995; and

WHEREAS, the Mayor and City Council of the City of LeRoy find that due to possible

transfers between departments by city employees it is possible that an employee, when requested to

transfer by the City from one department to another, may be unintentionally required to take a reduction in pay due to the hourly rate or salary differential as provided in Ordinance No. 589,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy,

McLean County, Illinois, in lawful meeting assembled, as follows:

589:

Section 1. Section 2. Salary and Pay Schedule for Appointed Officers and Employees (of the City of LeRoy) of Ordinance No. 589 is hereby amended by adding the following language at the end of Section 2., as the same exists after any amendments previously made to Ordinance No.

Any city employee transferring, either at the City's request, or with the City's approval, from one department to another shall be entitled to receive the same hourly rate or salary that said employee was receiving prior to the transfer, if said hourly wage or salary is higher than the hourly wage or salary provided under Ordinance No. 589 for the position or office into which the employee is transferring. For example, if a full-time street department employee, being paid a maximum hourly wage of \$9.80, transfers to the sewer department and is then categorized as a "sewer department employee - no licence" and is then entitled to receive \$9.62 as a maximum hourly wage, said employee would continue to receive the same rate of pay (\$9.80) as he or she had been entitled to receive under the category "street department employee - full-time".

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
