ORDINANCE NO. 609

AN ORDINANCE AMENDING CHAPTER 41 TRAFFIC, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended), BY AMENDMENT OF SECTION 41.30 - SPEED REGULATIONS

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interest on the residents of the City of LeRoy that Chapter 41, TRAFFIC of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), Section 41.30, be amended by addition of one or more speed zones, said additions to also be noted in an amended Schedule C to Chapter 41,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled follows:

Section 1. Section 41.30, Schedule C, Chapter 41, TRAFFIC, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by deletion of sub-item (i) of item 1 (20 Mile Per Hour Zones), and the relettering of sub-item (j) as new item (i).

Section 2. Section 41.30, Schedule C, Chapter 41, TRAFFIC, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of speed zones set forth as follows:

- (j) From East Washington Street and Barnett Street east (on East Washington Street) to the city limits.

Section 3. Schedule C attached to Chapter 41, TRAFFIC, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended as set forth in the attached Exhibit I, being Schedule C as amended by this ordinance.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law
