AN ORDINANCE AMENDING CHAPTER 7, SEWERS, MUNICIPAL CODE OF LE ROY, ILLINOIS, 1975, AND AN ORDINANCE AMENDING ORDINANCE 97, PART 3, ARTICLE 1, SEC. 3

WHEREAS, the Mayor and City Council of the City of LeRoy. Mclean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the city and its residents that the charge be increased for the basic user rate for sewer services in the City of LeRoy in order to better defray the expense to the city for handling and treating sewage in the city,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That Chapter 7, Municipal Code of LeRoy, 1975 (as amended), Part 3, Article 1, Section 3, Basic user rate, is hereby amended by deleting the figures "1.65" at the end of the fourth line of said section and by deleting the figures "1.25" in the middle of the seventh line of said section, and substituting therefor, respectively, "1.91" (in place of the "1.65") and "1.45" (in place of "1.25").

Section 2. Said substituted figures and the rates thereby established shall be effective beginning November 15, 1987.

Section 3 This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
