

**AN ORDINANCE AMENDING CHAPTER 4-STREETS, DITCHES AND TREES,  
MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED),  
IS HEREBY AMENDED BY ADDITION OF A NEW SECTION 4.15-TREE TRIMMERS**

**BE IT ORDAINED** by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

**Section 1.** Chapter 4, STREETS, DITCHES AND TREES, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new Section 4.15 in words and figures as follows:

**4.15 TREE TRIMMERS**

(a) License Required - It shall be unlawful to engage in the business of tree trimming in the City of LeRoy without first having obtained a license therefor. The annual fee for such license shall be \$10.00 and application shall be made in compliance with the general provisions of the City relating to licenses and permits. No such license shall be issued to anyone not having any license or other certification required by the State of Illinois.

(b) Trees On Public Property - No tree trimmer shall trim any tree on any public parkway or other property owned by the City of LeRoy without the permission of the Director of Public Works.

(c) Regulations To Be Obeyed - In trimming trees the following regulations shall be complied with:

(1) All applicable state and federal regulations and laws.

(2) Regulations adopted by the Director of Public Works of the City of LeRoy under authority hereby granted to said director to establish reasonable rules and regulations for the removal of trees on private property when the removal of said tree or trees may require placement of limbs, cuttings, wood or other debris on City right-of-way for pick-up or other disposition by the tree trimmer, or when City right-of-way shall be required, in the interests of public safety, to be blocked or barricaded for a period of time to facilitate the removal of one or more trees on private property.

(d) Revocation Of License - Any license issued under the provisions of this ordinance may be revoked for repeated violations of this ordinance or any provision hereof or of any other ordinance relating to the work done.

(e) Penalty - Any person, firm or corporation violating any of the provisions of this ordinance shall be fined not less than \$50.00 nor more than \$500.00 for each offense; and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.




