

**AN ORDINANCE REGARDING DONATION OF STREET  
LAMPS TO THE CITY OF LEROY**

**WHEREAS**, the City of LeRoy, the LeRoy Pride Action Committee, the LeRoy Historical Society, and other interested organizations and persons have undertaken a program to obtain lamp posts, consisting of five globes, for the improvement of the downtown business district area and downtown city park area in the City of LeRoy, and,

**WHEREAS**, the LeRoy Pride Action Committee is willing to collect donations on behalf of the City, purchase the lamps from time to time with the donations made on the City's behalf, and make the lamps available to the City from time to time on behalf of the donors purchasing the same, for donation to the City,

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. Individual lamps shall be obtained from contributions to purchase the same, said contributions being made on behalf of the City of LeRoy to the LeRoy Pride Action Committee, each contribution to be in the amount of \$550.00, which shall be the amount necessary to obtain one five-globe lamp, including the post and globes, and which donations shall include the City installing said lamp post in a place agreed to by the City and the LeRoy Historical Society, at no additional expense to the donor for the installation (the City hereby agreeing to bear the expense of installation, over and above the availability of funds from the \$550.00 per donor).

Section 2. The LeRoy Pride Action Committee shall purchase the lamp posts from time to time with the funds contributed and shall maintain an escrow account of unused funds from time to time pending the purchase of the next lamp posts, with any balance remaining from each \$550.00 donation, after application of the same to the purchase of one lamp post with five globes, being applied to the cost of installing the lamp post and connecting it to the city street lighting system.

Section 3. The City of LeRoy, upon request by an individual donor, will issue a letter affirming that a donation was made for the benefit of the City by way of purchase of a lamp which was then donated to the City for use in the program as previously outlined in this ordinance.

Section 4. The City of LeRoy agrees to be responsible, upon receiving the historical period design lamp posts from time to time for installation and maintenance of the same.

Section 5. Donors of the various lamp posts may have a plaque placed thereon indicating the lamp post was "donated by", "given by", "donated in honor of" or "in memory of", "dedicated to", or other such appropriate terms as the donor may wish to make known.

Section 6. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


I further certify that on May 15, 1995, the corporate authorities of such municipality passed and approved Ordinance No. 599, entitled:


