

AN ORDINANCE AMENDING SECTION 41.07 PARKING PROHIBITED, OF CHAPTER 41, TRAFFIC, MUNICIPAL CODE OF LeROY 1975 (AS AMENDED).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that the areas hereinafter described, all located within the City of LeRoy, Illinois, have become, during certain hours of the day and evening, places in which numbers of individuals in automobiles tend to congregate for no apparent purpose or reason, and

WHEREAS, the presence of the numbers of cars and individuals in the hereinafter designated areas tends to create traffic problems, and to be a source of excessive noise which is offensive and burdensome to the public and to the neighbors in the vicinity of the hereinafter described areas, and

WHEREAS, the Mayor and City Council deem it to be in the best interests of the citizens and of the City of LeRoy to establish conditions in the hereinafter designated areas making it less likely that groups of individuals and vehicles will congregate within such areas other than for established business, recreational, or civic purposes,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That Section 41.07 Parking Prohibited, of Chapter 41, Traffic, is hereby amended by designating on Schedule A attached to such Section and incorporated therein by reference the following additional designations of no parking zones or limited or controlled parking zones:

In accordance with Section 41.07 the following places are designated as no parking zones from 11:00 p.m. each day until 6:00 a.m. the succeeding day:

- a. South Mill Street, and the portion of LeRoy Schools' parking lot located on and along said part of Mill Street, in the Block between the South right-of-way line of East Center Street and the North right-of-way line of East Pine Street;
- b. Both sides of each street bordering the LeRoy Park District Swimming Pool to include both sides of Washington Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; both sides of Pearl Street in the portion of that street located between the North right-of-way line of Washington Street and the South right-of-way line of Warren Street; both sides of Warren Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; and both sides of East Street in the portion of that street located between the South right-of-way line of Warren Street and the North right-of-way line of Washington Street;

c. All parts of Main Street and Center Street around the city park located in the circle at the intersections of Center Street and Main Street, including the Northerly, Easterly, Southerly and Westerly bounds of the paved portions of said streets around the aforesaid park.

Section 2. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.






