**ORDINANCE NUMBER 06-09-02-90**

**AN ORDINANCE CHANGING THE NAME OF A PUBLIC STREET**

**WHEREAS**, the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, has as public roadway extending easterly off of Chestnut Street. The public roadway is between Chestnut Street and South East Street, this street is presently referred to as Maple Street, and

**WHEREAS**, the Mayor and City Council of the City of Le Roy deem it appropriate to rename the public street, said street being presently referred to as Maple Street

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

**Section 1.** That the name of Maple Street between Chestnut Street and South East Street is hereby changed from Maple Street to Sunset Drive.

**Section 2.** That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.






