**ORDINANCE NUMBER 14-10-01-90**

**AN ORDINANCE CHANGING THE NAME OR ADDRESS OF A PUBLIC STREET(S) WITHIN THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS**

**WHEREAS**, the City of Le Roy, McLean County, Illinois, an Illinois Municipal Corporation, has a public roadway beginning with the 400 Block of South Buck Road [from Vine Street intersection] and extending South through the 600 Block of what is currently referred to as, South Buck Road and;

**WHEREAS**, The City of Le Roy, McLean County, Illinois has been notified by the county GIS Addressing Tech for the ETSB (Emergency Telephone System Board) that a change of address number(s) is necessary, as mandated by them, at two structure locations currently referred to as 23 Salt Creek Road and; 107 Salt Creek Road which abut Salt Creek Road and;

**WHEREAS**, the Mayor and City Council of the City of Le Roy deem it appropriate to rename the public street, said street being presently referred to as South Buck Road and to change the addresses at two locations along Salt Creek Road.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

**Section 1.** That the name of South Buck Road beginning with the 400 Block [from the Vine Street intersection] and extending South through the 600 Block of what is currently referred to as South Buck Road is hereby changed from South Buck Road to South Buck Street.

**Section 2.** That the address of 23 Salt Creek Road will change to 300 Salt Creek Road and; 107 Salt Creek Road will change to 411 Salt Creek Road.

**Section 3.** That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.




