

ORDINANCE NO. 413

AN ORDINANCE CHANGING THE NUMERING OF BUILDINGS AND LOTS WITHIN THE
CITY OF LE ROY

Whereas, certain areas in the Conklings Addition to the City of Le Roy have been assigned designated street numbers; and

Whereas, said numbers have from time to time been assigned out of order to adjacent lots; and

Whereas, the city council has now determined that the street numbers in said areas are not consistent and have led to substantial confusion among the utility companies, post office personnel and the general public; and

Whereas, Chapter 24 of the Illinois Revised Statutes 1989 (as amended), Section 11-80-19 provides that the corporate authorities of each municipality within the State of Illinois may regulate the numbering of buildings and lots and may change the numbering of buildings and lots pursuant to said section of the Statutes,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Le Roy, Illinois, as follows:

Section 1. That the street numbers for the buildings and lots within the Conklings Addition shall be redesignated in accordance with Schedule A attached hereto and incorporated herein by reference.

Section 2. That the designated changes set forth in the attached schedule shall be effective not sooner than thirty (30) days after the election authorities having jurisdiction in said areas in which the numbering is changed and the post office branch serving said areas have each been notified by the City Clerk of the change of addresses in writing by certified mail.

Section 3. The City Clerk is hereby directed to expeditiously cause notice of these changes to be issued to the election authorities having jurisdiction in the area in which the numbering is to be changed and to the post office branch serving that area notifying said election and postal authorities that the numbering change shall take effect December 18, 1991. The City Clerk is further directed to cause notice of the change to be forwarded expeditiously to each of the residents and property owners whose addresses shall be affected by the changes set forth in the attached schedule.


Section 4. This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form as required by law.





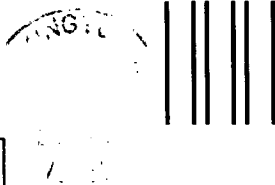
