

ORDINANCE No. 9

This Ordinance passed by a majority of the duly elected members of the City Council of the City of LeRoy, Illinois, on the 16th day of June, 1975 at a regularly scheduled meeting of said City Council,

W I T N E S S E T H:

WHEREAS, the City of LeRoy has previously advertised for bids for the construction of certain waterworks improvements according to specifications dated March 1975 and prepared by Farnsworth & Wylie, Consulting Engineers of Bloomington, Illinois in specifications known as "Specification No. 36," and

WHEREAS, said bids were to be submitted on or before June 10, 1975 at 10:00 a.m. to the said City of LeRoy, and

WHEREAS, said bids were submitted to the City of LeRoy and opened and tabulated at the time described above, and

WHEREAS, the City of LeRoy is desirous of accepting certain of the bids submitted,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois as follows:

1. The acceptance of bids and award of contracts as provided by this Ordinance shall be conditional upon the approval of the Farmers Home Administration of the United States of America of such award and shall also be conditional upon the Farmers Home Administration of the United States of America to finance the building of said waterworks improvements by the purchase of at least \$600,000.00 of water revenue bonds to be issued by the City of LeRoy, Illinois. If the Farmers Home Administration of the United States of America does not


approve the award of these bids and does not agree to finance the construction of said waterworks improvements by the purchase of \$600,000 of water revenue bonds from the City of LeRoy, Illinois, then the acceptance of bids and award of contracts made by this Ordinance shall be null and void and of no further effect whatsoever.

2. The following bidders are determined to be the low bidders as to the specifications described above and a contract is awarded to each bidder for the division of said specifications on which bids were submitted as follows:


<u>Name of Bidder</u>	<u>Division of Specifications Awarded</u>	<u>Amount of Bid</u>
a. J. L. Wroan & Sons, Inc.	A	\$258,650.00
b. Berner Plumbing & Heating	B	26,630.00
c. Caldwell Tanks, Inc.	C	159,105.00
d. J. L. Wroan & Sons, Inc.	D	33,292.60

3. Upon the final approval by the Farmers Home Administration of the United States of America as described above and upon the agreement of the Farmers Home Administration of the United States of America to purchase \$600,000.00 of Water Revenue Bonds from the City of LeRoy, Illinois to finance the construction of these waterworks improvements, then the Mayor of the City of LeRoy, Illinois shall notify the bidders described above of the award of contracts to them as described in this Ordinance.
