

**AN ORDINANCE AMENDING THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975
(AS AMENDED), CHAPTER 6, WATER SERVICE, SECTIONS 6.14 AND 6.15**

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY," has determined that it is necessary to change for its water system customers the minimum water usage for which to be billed and to change the billing cycle from a bi-monthly to a monthly cycle; and,

WHEREAS, it is the intention of the LeRoy City Council that the billings for garbage collection and sewer use also be changed to a monthly billing cycle in order to improve the cash flow of the CITY and to enable the CITY to operate more efficiently in its financial administration,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. That Chapter 6, Section 6.14, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby further amended by substituting in the fourth line of said section, which now reads "\$4.50 for the first 1,300 gallons used; and," by substitution of the numbers and symbol "\$2.25" for the numbers and symbol " \$4.50", and the numbers "650" for the the numbers "1,300" now found in the aforesaid line. It is the intention of the City Council of the City of LeRoy that the minimum charge for single family residential units and for single business water meters shall be \$2.25 for the first 650 gallons used per month.

SECTION 2. That Chapter 6, Section 6.15, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby repealed.

SECTION 3. That Chapter 6, new Section 6.15, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follows:

6.15 PAYMENT OF BILLS. Water meters shall be read on a monthly basis, with all water meters on the City water system being read each month. Statements for the amount due will be issued to water customers monthly and shall be due and payable within fifteen (15) days after date of statement. A penalty of ten percent (10%) will be added to the stated amount if not paid within fifteen (15) days, and CITY may at once shut-off the water supply until the arrearage has been paid, plus the amount

of \$5.00 for the cost of turning water off and \$5.00 for the cost of turning water on. All water accounts are payable only at the Office of the City Clerk, and all CITY officials are prohibited from extending credit to any water customer."


SECTION 4. This ordinance shall be in full force and effect **December 15, 1991**, and after its passage and publication in pamphlet form as required by law.






