**ORDINANCE NO. 10-02-02-42**

**AN ORDINANCE AMENDING TITLE 8, WATER & SEWER; CHAPTER ONE, WATER USE AND SERVICE; SECTION SEVEN, WATER RATES, ESTABLISHED OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 2003 (AS AMENDED)**

**WHEREAS**, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY" has determined that it is necessary and in the best interests of the CITY and its residents, that the basic user rates for water services be increased.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

**Section 1.** Title 8 of the Municipal Code of Le Roy, 2003 (as amended), Chapter 1, Section 7 is hereby repealed.

**Section 2.** Title 8 of the Municipal Code of Le Roy, 2003 (as amended), Chapter 1, Section 7, is hereby added in words and figures as follows:

**A. Inside Corporate Limits:**

1. After February 1, 2010: The water rates for all in city residential and business meters effective with the first meter reading after February 1, 2010, shall be as follows:

a. Individual Residences or Businesses:

- (1) Six dollars twenty-five cents (\$6.25) minimum for the first one thousand (1,000) gallons used; and
- (2) Six dollars twenty-five cents (\$6.25) for each one thousand (1,000) gallons beyond the minimum quantity.

b. More Than One Residence or Business: The water rates for meters serving more than one single-family unit or more than one business, or combination thereof, shall be:

- (1) Six dollars twenty-five cents (\$6.25) multiplied by the number of individual family units or businesses served from the meter to determine the minimum monthly charge; and
- (2) Six dollars twenty-five cents (\$6.25) for each one thousand (1,000) gallons beyond the minimum quantity used (as measured through the meter, regardless of the number of individual family units or businesses served from the meter).

2. After February 1, 2011: The water rates for all in city residential and business meters effective with the first meter reading after February 1, 2011, shall be as follows:

a. Individual Residences or Businesses:

- (1) Six dollars sixty cents (\$6.60) minimum for the first one thousand (1,000) gallons used; and
- (2) Six dollars sixty cents (\$6.60) for each one thousand (1,000) gallons beyond the minimum quantity.

b. More Than One Residence or Business: The water rates for meters serving more than one single-family unit or more than one business, or combination thereof, shall be:

- (1) Six dollars sixty cents (\$6.60) multiplied by the number of individual family units or businesses served from the meter to determine the minimum monthly charge; and
- (2) Six dollars sixty cents (\$6.60) for each one thousand (1,000) gallons beyond the minimum quantity used (as measured through the meter, regardless of the number of individual family units or businesses served from the meter).

3. After February 1, 2012: The water rates for all in city residential and business meters effective with the first meter reading after February 1, 2012, shall be as follows:

a. Individual Residences or Businesses:

- (1) Seven dollars zero cents (\$7.00) minimum for the first one thousand (1,000) gallons used; and
- (2) Seven dollars zero cents (\$7.00) for each one thousand (1,000) gallons beyond the minimum quantity.

b. More Than One Residence or Business: The water rates for meters serving more than one single-family unit or more than one business, or combination thereof, shall be:

- (1) Seven dollars zero cents (\$7.00) multiplied by the number of individual family units or businesses served from the meter to determine the minimum monthly charge; and
- (2) Seven dollars zero cents (\$7.00) for each one thousand (1,000) gallons beyond the minimum quantity used (as measured through the meter, regardless of the number of individual family units or businesses served from the meter).

B. Outside Corporate Limits: One hundred percent (100%) will be added to the above rates to metered customers outside the corporate limits of the city.

C. Increase In Rates: Effective February 1, 2013, water user fees will be increased based on the "Consumer Price Index All Urban Consumers (CPI-U)". Any adjustment will be made effective with the first meter reading after February 1 and will be in effect for one year. The consumer price index inflation rate will be evaluated on an annual basis each February, and adjustments will be made accordingly.

**Section 3.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.




