

**ORDINANCE NO. 13-01-02-42**

**AN ORDINANCE AMENDING TITLE 8, WATER & SEWER; CHAPTER ONE, WATER USE AND SERVICE; SECTION SEVEN, WATER RATES, ESTABLISHED OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 2003 (AS AMENDED)**

**WHEREAS**, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY" has determined that it is necessary and in the best interests of the CITY and its residents to amend Chapter 1 of Title 8, Water Use and Service by adding 8-1-7 D. Water Tower Rehabilitation, of the Municipal Code of the City of Le Roy, McLean County, Illinois, 2003 (as amended) and;

**WHEREAS**, the City of Le Roy will incur over \$275,000.00 as a capital expenditure to rehabilitate the 250,000 gallon South elevated water tower; and

**WHEREAS**, the City of Le Roy has applied to the Illinois Environmental Protection Agency (I.E.P.A.) for a 20 year loan which if approved, would require a Capital Expenditure Fee to cover debt payments; and

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

**Section 1.** Title 8 of the Municipal Code of Le Roy, 2003 (as amended), Chapter 1, Section 7, is hereby added in words and figures as follows:

**D. Water Tower Capital Expense Fee:**

1. After February 1, 2013 all utility customers of the City of Le Roy will be required to pay a \$2.00 per month fee. This fee will begin on the first bill prepared after the 1<sup>st</sup> day of February 2013 and will continue until project debt is paid or as I.E.P.A. loan commitment has been fulfilled, no later than February 1, 2033.

**Section 2.** All ordinances or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

**Section 3.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.






