AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975, CHAPTER 6, WATER SERVICE, SECTIONS 6.14 and 6.15.

WHEREAS THE CITY OF LE ROY has determined to assess a User fee for the use of the City sewage system, and

WHEREAS the billings for the sewer use fees and for the water use fees are intended to be billed at the same time, and

WHEREAS the billing periods for the sewer use fee shall be bi-monthly,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois:

Section 1. That Chapter 6, Section 6.14 of the Municipal Code of LeRoy, Illinois (1975) as amended, is hereby further amended by amending said section to read:

"6.14 WATER METER RATES. The water rates for all single residences and single business meters shall be as follows:

\$4.50 for the first 1,300 gallons used; and
\$2.00 for every 1,000 gallons beyond the minimum quantity.

The water rates for single meters serving more than one single family unit or more than one business, or combination thereof, shall be:

\$4.50 multiplied by the individual family units or businesses served from the one meter to determine the minimum charge; and

\$2.00 for each 1,000 gallons beyond the minimum quantity used computed by multiplying 1,000 gallons by the number of individual family units or businesses served from the one meter.

Fifty per cent (50%) will be added to the above rates to metered customers outside the corporate limits of the City of LeRoy."

Section 2. That Chapter 6, Section 6.15 of the Municipal Code of LeRoy, Illinois (1975) as amended, is hereby further amended by amending said section to read:

"6.15 PAYMENT OF BILLS. Water meters shall be read on a staggered bi-monthly basis, approximately one-half of the total number being read each month. Statements for the amount due will be issued to water customers bi-monthly established for each account and shall be due and payable within fifteen (15) days after date of statement. A penalty of ten per cent (10%) will be added to the stated amount if not paid within fifteen (15) days, and the City may at once shut off the water supply until arrears have been paid, plus the amount of \$3.00 for costs of turning water off and on.

All water accounts are payable only at the office of the City Clerk, and all City officials are positively prohibited from extending credit to any water customer."

Section 3. This Ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.

PASSED by the Mayor and City Council of the City of LeRoy, Illinois, on the 4th day of June, 1979, and deposited and filed in the office of the City Clerk in said City on that date.
