AN ORDINANCE TRANSFERRING THE AUTHORITY OF THE CITY OF LEROY TO LICENSE AND REGULATE RAFFLES WITHIN THE CORPORATE LIMITS OF SAID CITY OT THE COUNTY OF MCLEAN

AN ORDINANCE TRANSFERRING THE AUTHORITY OF THE CITY OF LEROY TO LICENSE AND REGULATE RAFFLES WITHIN THE CORPORATE LIMITS OF SAID CITY TO THE COUNTY OF MC LEAN.

Whereas, Illinois Revised Statutes, Chapter 85, Section 2302, authorizes units of local government to license and regulate raffles within their jurisdictions and in the manner prescribed therein; and

Whereas, the County of McLean and the City of LeRoy have entered into an Intergovernmental Agreement providing that each governing body shall join in the licensing of organizations to operate raffles in accordance with Illinois Revised Statutes, Chapter 85, Section 2301 et seq., as amended; and

Whereas, the County of McLean has enacted an ordinance pursuant to Illinois Revised Statutes, Chapter 85, Section 2301 et seq., as amended, which operates within all of the area of McLean County and also within the corporate limits of any city, town or village of McLean County where there is in effect a written contract between the governing body of said city, town or village and the County Board of McLean County providing for the joining of each governing body in the licensing and regulation of raffles as described previously; and

Whereas, a transfer of the authority of the City of LeRoy to license and regulate raffles pursuant to Illinois Revised Statutes, Chapter 85, Section 2302, to the County of McLean must be accomplished in order to achieve the goals of both parties to the aforesaid Intergovernmental Agreement,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

- Section 1. That all licensing and regulatory authority of the City of LeRoy to license and regulate raffles pursuant to Illinois Revised Statutes, Chapter 85, Section 2301 et seq., as amended, within the corporate limits of said City, is hereby transferred to the County of McLean, a body politic and corporate.
- Section 2. That said transfer of authority, made in accordance with the aforesaid Intergovernmental Agreement, attached hereto as Exhibit 1 and incorporated herein by reference, shall be exercised by the County of McLean until such time as either the City of LeRoy or the County of McLean shall withdraw from said Intergovernmental Agreement and give the proper notice as required therein to the other party.
- Section 3. That this transfer of authority shall continue in effect regardless of any amendments to the current ordinance of the County of McLean regarding the licensing and regulation of raffles, and that any amendment made from time to time by the McLean County Board to said ordinance may be made without the approval of any said amendment or amendments by the corporate authorities of the City of LeRoy.

INTERGOVERNMENTAL AGREEMENT

WHEREAS, Illinois Revised Statutes, Chapter 85, Section 2302, authorizes units of local government to license and regulate raffles within their jurisdiction and in the manner prescribed therein, and

WHEREAS, County of McLean has enacted an Ordinance pursuant to Illinois Revised Statutes, Chapter 85, Section 2301 et seq., which operates within all of the area of McLean County outside the corporate limits of any city, town, or village, and also within the corporate limits of any city, town, or village in McLean County, where there is in effect a written contract between the governing body of said city, town or village and the County Board of McLean County providing for both said city, town or village and said county to join in the licensing of organizations to operate raffles; and

WHEREAS, it is the desire of the City of LeRoy and the County of McLean to regulate and license raffles within the corporate limits of the City of LeRoy, Illinois, and to do so in as expeditious and efficient a manner as possible; and

WHEREAS, a transfer of the authority of the City of LeRoy to license and regulate raffles pursuant to Illinois Revised Statutes, Chapter 85, Section 2302, to the County of McLean will meet those ends,

IT IS, THEREFORE, AGREED by and among the City of LeRoy, Illinois, an Illinois municipal corporation, and the County of McLean, a body politic and corporate in the State of Illinois, as follows:

- 1. The corporate authorities of the City of LeRoy will adopt an Ordinance transferring all of its authority under Illinois Revised Statutes, Chapter 85, Section 2301 et seq., to license and regulate raffles within their corporate limits to the County of McLean. The Clerk of the City of LeRoy shall transmit a certified copy of said Ordinance to the County Clerk of McLean County. The authority contained in said Ordinance shall take effect immediately upon delivery to the County Clerk.
- The McLean County Ordinance may be amended from time to time as the McLean County Board sees fit, without the need for any approval of said Amendments In the event that said Ordinance is amended, the by the City of LeRoy. McLean County Board shall cause a copy of said amended section or sections to be promptly forwarded to the corporate authorities of the City of LeRoy for their information.
- The County shall be entitled to retain all license fees, fines and penalties collected pursuant to its licensing and regulation of raffles, pursuant to this Agreement and the enforcement of its Ordinances.
- Any party to this Agreement may withdraw by giving a notice of intent to do so to the Clerk of the other governing authority. Such notice shall be given by delivery of a certified copy of a kesolution of intent to withdraw adopted by the corporate authorities of the withdrawing governing body. Said withdrawal shall take effect thirty (30) days after the delivery of said notice and shall be effective as to all raffles which have not been licensed prior to the effective date of the withdrawal. Said withdrawal shall be effective notwithstanding the failure of any other party of this Agreement to amend its Ordinances or take other action to implement said withdrawal.
- This Agreement is executed pursuant to the authority granted under tilinois Revised Statutes, Chapter 85, Section 2301 et seq., as amended by P. A. 82-0711, approved and effective 12 November 1981; and pursuant to the City of LeRoy's and County of McLean's authority under Article 7, Section 10, of the 1970 Constitution of the State of Illinois.
