ORDINANCE NO. 172

AN ORDINANCE AMENDING THE MAXIMUM SCHEDULE OF RATES CHARGEABLE BY CABLE TELEVISION COMPANY OF ILLINOIS, ITS SUBSIDIARIES, AFFILIATES, LESSEES, SUCCESSORS AND ASSIGNS, UNDER THE FRANCHISE PREVIOUSLY GRANTED TO SAID COMPANY FOR THE PURPOSE OF OPERATING A COMMUNITY ANTENNA TELEVISION SYSTEM WITHIN THE CITY OF LeROY.

Whereas, the Mayor and City Council of the City of LeRoy have received information from Cable Television Company of Illinois that its operating expenses and installation expenses for a community antenna television system within the city limits of the City of LeRoy have increased within the last 12 months; and

Whereas, the Mayor and City Council of the City of LeRoy believe that it is in the best interests of the City of LeRoy and of its citizens to encourage the maintenance and operation of a community antenna television system in a manner that will assure the most reasonable quality of service and product at a reasonable expense to the user,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1: That Section 5. RATES, Ordinance No. 125, adopted September 2, 1980, and Schedule A thereto, are hereby amended as follows:

Section 2: That the basic subscriber fee as amended by Section 1 of this ordinance shall become effective January 1, 1983, and until such time the current basic subscriber fee shall remain in effect; and that the subscriber fee - pay channel (premium service) as amended by Section 1 of this ordinance shall become effective July 1, 1983, and that until such time the current subscriber fee - pay channel (premium service) shall remain in effect.

Section 3: That all other proposed rates and fees shall remain the same as set forth in Schedule A under Section 1 of this ordinance.

Section 4: That this ordinance shall be in full force and effect upon final passage of the ordinance and publication in pamphlet form as required by Illinois law and by the ordinances of the City of LeRoy.


