ORDINANCE NO. 12

At a regular meeting of the City Council of the City of LeRoy, held at the City Hall, LeRoy, Illinois on April 3, 1978, the following Ordinance was adopted:

WHEREAS, George A. Staley and Viola C. Staley have filed a petition for annexation of certain real estate described in an annexation plat, a copy of which is incorporated herein and made a part hereof by reference;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The City Council of the City of LeRoy, Illinois finds as follows:

A. That the property to be annexed is contiguous to existing corporate limits of the City of LeRoy;

B. That the petitioners are the sole owners of the property to be annexed;

C. That there are no electors residing on said premises;

D. That the territory to be annexed is now a part of the LeRoy Community Fire Protection District and that the annexation will effect no change therein, and that, therefore, no notice is required to be sent to said Fire District.

NOW, THEREFORE, IT IS RESOLVED that the following described real estate: See legal description attached as Exhibit A hereto, is annexed to the City of LeRoy, Illinois.

THIS ORDINANCE is effective on the date it is passed.

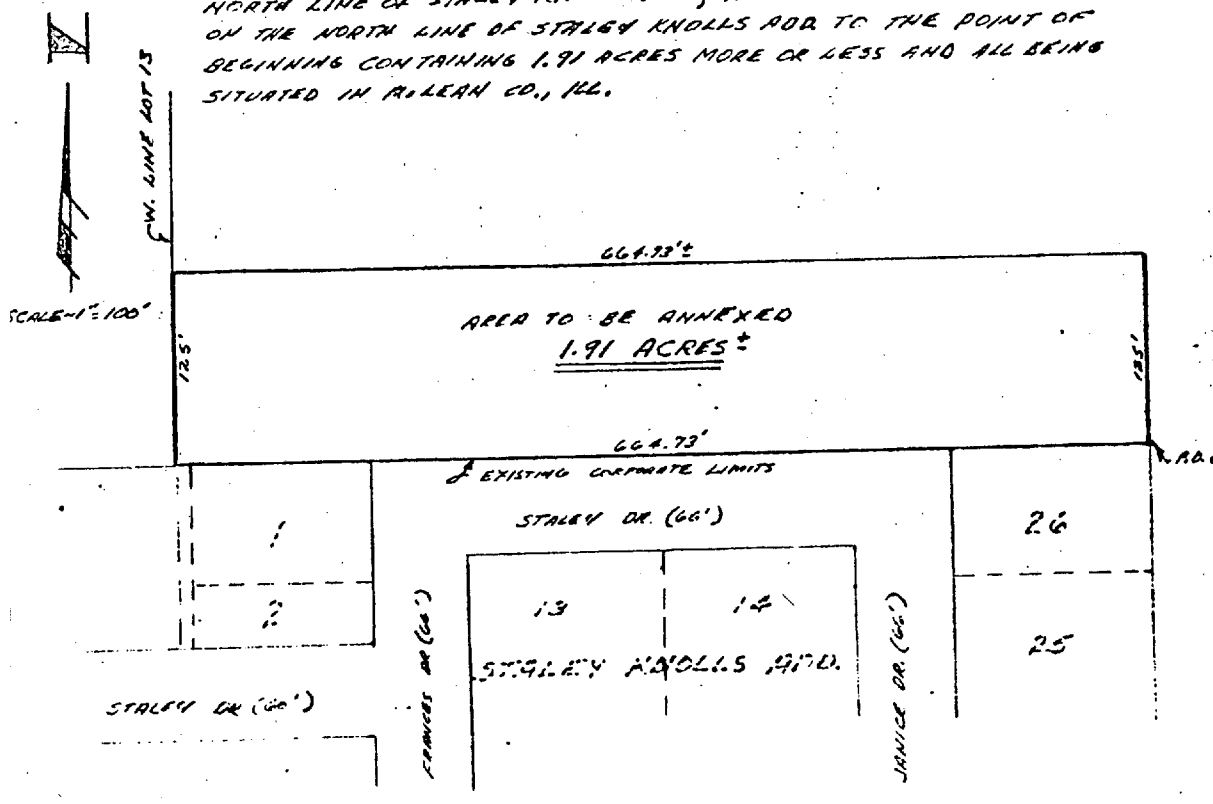

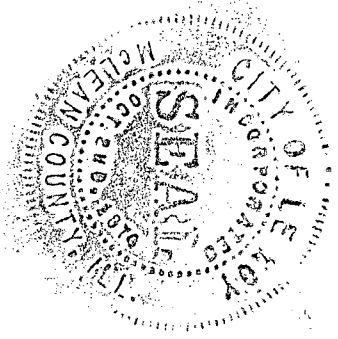
