ORDINANCE NO. 344

AN ORDINANCE AMENDING ORDINANCE NUMBER 2, DATED FEBRUARY 18, 1975, BEING AN ORDINANCE DESIGNATING THE OFFICIAL DEPOSITORY FOR FUNDS OF THE CITY OF LEROY, ILLINOIS.

WHEREAS, ON February 18, 1975, The LeRoy State Bank and the LeRoy Savings and Loan Association, both of the City of LeRoy, Illinois, were designated as official depositories of any and all funds of this City or any branch thereof, and,

WHEREAS, THE Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interest of the City to designate the LeRoy State Bank and LeRoy Federal Savings, a division of First Federal Savings of Bloomington, Illinois, as the official depositories for any and all funds of this City or any branch or agency thereof, and

WHEREAS, Section I of Ordinance Number 2, dated February 18, 1975, designates LeRoy Savings and Loan Association as one of the two depositories for City funds, and,

WHEREAS, LeRoy Savings and Loan Association has been acquired duly and lawfully by First Federal Savings of Bloomington, Illinois, and operates as a division thereof, the name of LeRoy Savings and Loan Association is hereby stricken from the Ordinance Number 2, and substituted with the name LeRoy Federal Savings, a division of First Federal Savings of Bloomington, Illinois.


THEREFORE, this amendment to Ordinance Number 2, dated February 18, 1975, amends and clarifies Section I of the original ordinance, and all ordinances of this City in conflict herewith are repealed, and this Ordinance shall be in full force and effect from and after its passage as provided by law.






