ORDINANCE NO. 194

WHEREAS, A petition to rezone the following described real estate:

West one-half of Lot 4 and All of Lots 5, 6 & 7,  
Block 49, Conklings Addition

seeks to rezone said premises from a Classification of R-1, 1 & 2 Family Residential to R-2, General Residential, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois on Thursday, September 29, 1983 at 7 P.M. in the City Hall, in accordance with law to consider said Petition, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois approval of said Petition for change of zoning classification of the above described premises, and

WHEREAS, all things required by law to be done in and about the rezoning of said property have been completed:

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Le Roy, Illinois as follows,

The Zoning Ordinance for the City of Le Roy, Illinois which was adopted on the 16th day of June, 1975, as amended, is amended by amending the Zoning Ordinance, to provide that the premises described above shall henceforth be zoned R-2, General Residential.

The above ordinance was adopted by a vote of 6 votes for and 0 votes against at a regular meeting of the City Council of the City of Le Roy, held at the City Hall for the City of Le Roy, on the 6th day of February, 1984.


I, Juanita Dagley, certify that I am the duly elected and acting City Clerk of the City of Le Roy, McLean County, Illinois.
