## ORDINANCE NO. 655

AN ORDINANCE AMENDING THE NUMBERING OF CERTAIN SUB-PROVISIONS OF CHAPTER 3, CITY ADMINISTRATION, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, it has been brought to the attention of the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, that Ordinance No. 93, passed and approved on May 7, 1979, providing for the establishment of the office of City Collector, was codified as Section 3.09 of the Municipal Code of the City of LeRoy, Illinois 1975 (as amended), and

WHEREAS, it has also come to the attention of the Mayor and City Council of the City of LeRoy that Ordinance No. 204 providing for emergency powers for the Mayor of the City of LeRoy, passed and approved July 2, 1984, was also codified as Section 3.09 of Chapter 3, City Administration, Municipal Code of LeRoy, Illinois, 1975 (as amended),

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

- Section 1. Ordinance No. 93, establishing the office of City Collector and providing various duties thereof is hereby recodified as Section 3.02.5 of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended).
- Section 2. Ordinance No. 204, Emergency Powers of the Mayor of the City of LeRoy, shall continue to be codified as Section 3.09 of Chapter 3, City Administration, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended).
- <u>Section 3</u>. All ordinances, or parts thereof, and resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.
- <u>Section 4</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
