ORDINANCE NO. 813

AN ORDINANCE AMENDING ORDINANCE NO. 226, GRANTING A ZONING VARIANCE, AND GRANTING PERMISSION FOR THE KEEPING AND BOARDING OF ANIMALS FOR SPECIFIC PROPERTY DESCRIBED HEREIN, IN THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, a Petition to permit a use variance for the real estate described hereinafter was received by the City of LeRoy, in regard to premises described hereinafter, said petition seeking a variance to permit the keeping and boarding of animals; and

WHEREAS, a public hearing was held was by the Zoning Board of Appeals of the City of LeRoy, Illinois, on September 10, 1998, at 7:00 PM, at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of LeRoy, Illinois, that said petition for variation in use be allowed as requested; and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the zoning regulations regarding the hereinafter described property have been completed; and

WHEREAS, the City of LeRoy did, by Ordinance No. 226, passed and approved December 10, 1984, provide as to the zoning designation for said premises that said premises would be zoned A, Agriculture, and that certain additional permitted uses as set forth in an annexation agreement, a copy of which was made an exhibit to the aforesaid ordinance, would be allowed, and such additional permitted uses would not be construed to permit "riding stables, petting zoos, or any other similar use of subject premises where such use may involve the keeping or boarding of animals upon the subject premises, or the placement for viewing or recreational purposes of animals upon the subject premises from time to time, other than to the extent city ordinances permit the same, without further application in writing, to the zoning board and city council of the City of LeRoy for appropriate hearing thereon, and favorable action being taken in connection with such application, if made,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. The real estate the subject of this ordinance is described as follows:

(See Exhibit A attached hereto and incorporated herein by reference).

SECTION 2. The City Council hereby finds that as to the real estate described in Exhibit A, attached hereto and incorporated herein by reference, an additional permitted use in the A, Agriculture District, which is the zoning district classification for the subject premises, shall be deemed to include keeping or boarding of animals for agricultural purposes, including the keeping or boarding of horses.

SECTION 3. This ordinance shall be deemed to amend Ordinance No. 226, in accordance with the provisions of this ordinance.

SECTION 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
