**AN ORDINANCE APPROVING A VARIATION IN SIGN HEIGHT
RESTRICTION OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975
(as amended)
CHAPTER 21 - ZONING**

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in sign height restriction of 35 feet to a 70 feet height to allow for the construction of a 70 foot illuminated sign which would be visible from the interstate.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on June 8, 2000 at 7:32 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for variation in sign height restriction of 35 feet to a height of 70 feet to allow for the construction of a illuminated sign.

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

**Lot 7 of Golden Centre Subdivision,
City of Le Roy, County of McLean, Illinois**

variances in the zoning ordinance sign height restriction of 35 feet is hereby granted to allow for the construction of a 70 foot illuminated sign on the previously described land; said variance being from a 35 feet height restriction to a 70 feet height restriction to allow construction of a 70 foot illuminated sign.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.


