ORDINANCE NO. 468

**ORDINANCE AMENDING LICENSE FEES  
FOR AMUSEMENT DEVICES, AND AMENDING  
CHAPTER 32, SECTION 32.05-AMUSEMENT DEVICES (b)**

**WHEREAS**, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City of LeRoy and its residents that the maximum limit be placed on license fees required to be paid annually for skill or other entertainment devices, the same being also referred to as "amusement devices,"

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

**Section 1.** Section 32.05-AMUSEMENT DEVICES (b), of Chapter 32 BUSINESS REGULATIONS, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of the following words at the end of the first sentence thereof:

License fees for skill or other entertainment devices (\$50.00 per year per device) shall not exceed a maximum of \$500.00 per building, room or public place in the City, it being the intention of the City that at one location under the name of one owner of the business at that location that should the owner have more than ten (10) machines at the location that the maximum fee due annually for the license for all skill and entertainment devices at that location under the same ownership shall not exceed \$500.00.

**Section 2.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
