**AN ORDINANCE AMENDING LICENSE FEES  
FOR AMUSEMENT DEVICES, AND AMENDING  
CHAPTER 32, SECTION 32.05 - AMUSEMENT DEVICES**

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City of LeRoy and its residents that the maximum limit placed on license fees required to be paid annually for skill or other entertainment devices be reduced, such devices being referred to as "amusement devices,"

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

**Section 1.** Ordinance No. 517 and Section 32.05 - Amusement Devices (b), of Chapter 32, Business Regulations, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), are hereby amended by deletion and repeal of the aforesaid subsection (b) and of Ordinance No. 517 in their entirety.

**Section 2.** Section 32.05 - Amusement Devices, of Chapter 32, Business Regulation, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new subsection (b) in those words and figures as follows:

License fees for skill or entertainment devices shall be \$100.00 per year for one or more machines, said fee to be paid for the privilege of having one or more such machines at any location. Such fee shall be due per building, room or public place of the City, it being the intention of the City that at one location under the name of one owner of the business at that location that should the owner have any such skill or entertainment machines at said location the fee due annually for the license for such skill or entertainment devices at that location under the same ownership shall be \$100.00 per year. Any number of skill and/or entertainment and machines or devices may be had at each location for the payment of the annual fee as aforesaid.

**Section 3.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


