**ORDINANCE NO. 06-09-04-50**

**AN ORDINANCE AMENDING TITLE 4; CHAPTER 1, SECTION 6 (ABATEMENT PROCEDURES) OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003**

**WHEREAS**, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the abatement procedure; and

**WHEREAS**, the Mayor and City Council of the City of Le Roy have determined that several said changes need to be made, being in the best interest of the city and its residents; and

**NOW, THEREFORE BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** That Title 4, Public Nuisances, of the municipal Code of Le Roy, Illinois 2003, 4-1-6A is hereby amended by the addition of the word “a” in the first sentence between the word whenever and complaint, it now reads “Whenever a complaint”.

**SECTION 2.** That Title 4, Public Nuisances, of the municipal Code of Le Roy, Illinois 2003, 4-1-6B1 is hereby amended by substitution of “code compliance officer” in place of “city clerk”.

**SECTION 3.** That Title 4, Public Nuisances, of the municipal Code of Le Roy, Illinois 2003, 4-1-6B1 is hereby amended by substitution of “seven (7) days” in place of “ten (10) days”

**SECTION 4.** That Title 4, Public Nuisances, of the municipal Code of Le Roy, Illinois 2003, 4-1-6-B2 is hereby amended by substitution of “seven (7) days” in place of “ten (10) days”.

**SECTION 5.** That Title 4, Public Nuisances, of the municipal Code of Le Roy, Illinois 2003, 4-1-6-B2 is hereby amended by substitution of the word “may” in place of the word “my”, which is between the words city and proceed. It now reads, “city may proceed”.

**SECTION 6.** That Title 4, Public Nuisances, of the municipal Code of Le Roy, Illinois 2003, 4-1-6-B4 is hereby amended by the addition of the sentence, “All fees associated with the lien and the lien release filing will be added to lien at the time of filing.” This additional sentence will now appear as the last sentence in 4-1-6B4.

**SECTION 7.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.


