ORDINANCE NO 01-04-01-50

**AN ORDINANCE EXTENDING AN ELECTRIC FRANCHISE AGREEMENT WITH ILLINOIS POWER**

**WHEREAS**, the City of LeRoy is a unit of local government with authority to legislate in matters concerning its local government and affairs; and

**WHEREAS**, the current electric franchise agreement expired on January 30, 2001; and

**WHEREAS**, it is in the best interests of the health, safety and welfare of the citizens of LeRoy to extend the existing electric franchise agreement; and

**WHEREAS**, all Ordinances, or parts of Ordinances, in conflict herewith are hereby repealed effective upon the effective date of this Ordinance; and

**WHEREAS**, this Ordinance shall be in force and effect from and after its passage, acceptance and, if necessary, its recordation.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LE ROY, ILLINOIS:**

That the existing electric franchise ordinance 394 is hereby extended for 90 days and will be renewed automatically for additional 90-day periods unless canceled by either party with at least 45 days notice prior to the expiration of the initial term or any subsequent term. The extension can also be canceled immediately by agreement of both parties.


