

ORDINANCE NO. 17-07-02-50

AN ORDINANCE AMENDING
TITLE THREE, CHAPTER SIX OF THE MUNICIPAL CODE FOR THE CITY OF LE ROY,
McLEAN COUNTY, ILLINOIS

WHEREAS, the City of Le Roy is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, the City desires to amend the City's Peddlers, Solicitors and Transient Merchants within Title Three Chapter six regulations; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

Section 1. Recitals. The Council hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.

Section 2. Amendment to Section 3-6-6. Section 3-6-6 of the City of Le Roy Code of Ordinances, entitled "Time Limit on Soliciting and Peddling" which shall read as follows:

It is hereby declared to be unlawful and shall constitute a nuisance for any person, whether registered under this chapter or not, to go upon any premises and ring the doorbell upon or near any door of a residence located thereon, or rap or knock upon any door, or create any sound in any other manner calculated to attract the attention of occupant of such residence, for the purpose of securing an audience with the occupant thereof and engage in "soliciting" as defined in section 3-6-1 of this chapter prior to nine o'clock (9:00) A.M. or after **seven** o'clock (**7:00**) P.M. **In addition, no soliciting and or peddling will be allowed on any Sunday or recognized holiday.**

Section 4. Conflict. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 5. Effective Date. This Ordinance shall be in full force and effect following its passage and approval as required by law.






