# ORDINANCE 10-01-01-10

## AN ORDINANCE AMENDING TITLE ONE, ADMINISTRATION CHAPTER FOUR, GENERAL PENALTY, SECTION THREE, SETTLEMENT OF CERTAIN ORDINANCE VIOLATIONS, MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003 (as amended)

Whereas, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the residents of the City of Le Roy that Title One, Administration, Chapter Four, General Penalty, Section Three, Settlement of Certain Ordinance Violations, Municipal Code of Le Roy, Illinois, 2003 (as amended), be amended to provide an addition to the fine fee,

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, McLean County, Illinois, in lawful meeting assembled, as follows:

**Section 1. Chapter Four, General Penalty**, of the Municipal Code of Le Roy, Illinois, 2003 (as amended), is hereby amended by adding the following to Title One, Administration, Chapter Four, General Penalty, Section Three, Settlement of Certain Ordinance Violations, Subsection 6 Nuisances(1-4-3-6):

Nuisances		1 <sup>st</sup> Offense	2 <sup>nd</sup> Offense	3 <sup>rd</sup> /Subsequent Offense
Public Indecency	4-1-4F	\$50.00	\$100.00	\$150.00

**Section 2.** All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

**Section 3.** Nothing in this ordinance hereby adopted shall be constructed to affect any suite or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 2 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

**Section 4.** This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.






