

AN ORDINANCE AUTHORIZING THE ISSUANCE OF TAX ANTICIPATION WARRANTS IN ANTICIPATION OF TAXES LEVIED FOR THE YEAR 1979 OF THE CITY OF LeROY, McLEAN COUNTY, ILLINOIS.

WHEREAS, there is not sufficient money in the Treasury of this City to meet and defray the necessary expenses of government; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, deem it advisable, necessary and for the best interest of this City that funds be borrowed for the purpose of meeting and defraying the necessary expenses of the City and in evidence thereof to issue its tax anticipation warrants in anticipation of the taxes of said City for General Corporate Purposes, for the collection and disposal of garbage, trash, refuse and ashes, and for the audit of the accounts of the City, all said taxes being levied for the year 1979,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, as follows:

Section 1. That money be borrowed from time to time, as needed, to meet and defray the necessary expenses of this City against and in anticipation of the collection of the tax levy for the year 1979 for General Corporate Purposes, for the collection and disposal of garbage, trash, refuse and ashes, and for the audit of the accounts of the City for the fiscal year 1979-1980, said warrants to bear interest not to exceed seven per cent (7%) per annum, from their date until paid or until notice shall be given by publication in a newspaper or otherwise that the money for their payment is available and will be paid on presentation, such warrants to show upon their face that they are payable in the numerical order of their issue and solely from such taxes when collected, and shall be received by any collector of taxes in payment of the tax against which they are issued. Such warrants shall not be issued in excess of eighty-five (85%) of the total amount of the tax so levied, which said tax is hereby assigned and pledged to the payment of said warrants, and such taxes when collected shall be set apart and held for their payment.

Section 2. That said warrants shall be in substantially the following form:

KNOW ALL MEN BY THESE PRESENTS, that the City of LeRoy, in the County of McLean and State of Illinois, will pay to bearer at the office of the City Treasurer, in the City of LeRoy, Illinois, the sum of _____ (Dollars) (\$ _____) with interest thereon at the rate of _____ per cent (_____) per annum from date hereof until paid or until notice shall be given, by publication in a newspaper or otherwise, that the money for its payment is available and that it will be paid on presentation.


Principal hereof and interest hereon will be paid in lawful money of the United States of America from the proceeds, when received, of taxes, heretofore levied upon all the taxable property in the City of LeRoy, for the year 1979 for General Corporate Purposes, for The Collection and Disposal of Garbage, Trash, Refuse and Ashes, and for The Audit of The City Accounts for fiscal year 1979-1980.

This warrant is issued in anticipation of said taxes so levied for the year 1979 for General Corporate Purposes, for The Collection and Disposal of Garbage, Trash, Refuse and Ashes, and for The Audit of the City Accounts for fiscal year 1979-1980 to provide a fund to meet and defray the ordinary and necessary expenses of the City of LeRoy, and both principal and interest are payable solely from said taxes when collected, and not otherwise, which taxes are hereby assigned and pledged to the payment of this warrant and of all warrants issued against and in anticipation of such taxes, the total of which warrants so issued does not exceed eighty-five (85%) per cent of tax levy made therefor, and shall be received by any collector of taxes in payment of the tax against which it is issued.

This warrant and all other warrants issued in anticipation of the collection of the 1979 General Corporate Purpose Tax, special tax for The Collection and Disposal of Garbage, Trash, Refuse and Ashes, or special tax for The Audit of The City Accounts for fiscal year 1979-1980 are payable in the numerical order of their issuance.

IT IS HEREBY CERTIFIED that all acts, conditions and things required by law to be done precedent to and in the issuance hereof have been properly done, have happened and have been performed as authorized by the Ordinances of said City adopted pursuant to the applicable provisions of "The Illinois Municipal Code" and all laws amendatory thereof and supplemental thereto.

ORDINANCE NO. 113


AMENDMENT TO ORDINANCE NO. 70

BE IT ENACTED by the CITY COUNCIL, CITY OF LE ROY, at a regular meeting held on April 21, 1980 that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

2 STOP SIGNS 1 to be installed at east exit on Dove Ave.
 1 to be installed at east exit on Cardinal Drive

Violation of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois in Chapter 41.
