ORDINANCE NO. 772

WHEREAS, the City of LeRoy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, a majority of the corporate authorities now holding office have determined that it is necessary, appropriate, and in the best interests of the City of LeRoy to extend the sale date from December 15, 1997, to January 19, 1998;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

PASSED by the City Council of the City of LeRoy, Illinois, upon the motion by Dawn Thompson, seconded by Dick Oliver, by roll call vote on the 15th day of December, 1997, as follows:

Section 1: That the 1978 Ford two-ton flatbed truck (VIN: F70EVBA6150), the 1971 Chevrolet van (VIN: GS151U138512), and the 1983 Chevrolet S-10 pickup truck with longbed and topper (VIN: IGCBS14A7D2160611), be sold by the City of LeRoy by sealed bid to be opened at the regular City Council meeting on January 19, 1998. Persons presenting sealed bids shall have the right, if in attendance at the meeting, either in person or through their agent, to raise their bid at the meeting. Further, the Director of Public Works is directed to advertised in the newspaper and in such other manner as he may feel appropriate to solicit sealed bids to be submitted to the City in such manner as may be appropriate, either in person, by mail, or both, such sealed bids to be submitted at such time and date as the Public Works Director shall indicate in the advertisement, but in no event later than 7:00 p.m., January 19, 1988. Each sealed bid shall clearly indicate on the outside that vehicle as to which it is intended to be submitted. The City

Council hereby reserves the right, and that shall be indicated in the advertising, to refuse any and all bids.

Section 2: Any bid that is accepted at the City Council meeting on January 19, 1998, shall be considered a final sale upon its acceptance and the effective date of the sale shall be ratified as of January 19, 1998.
