

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975, CHAPTER 33, OCCUPATION AND USE TAXES, SECTION 33.01 "MUNICIPAL RETAILERS' OCCUPATION TAX" and SECTION 33.02 "MUNICIPAL SERVICE OCCUPATION TAX".

Whereas, SB 736 (Public Act 80-1292) effective August 2, 1978, has been adopted by the Illinois General Assembly, and

Whereas, said Act amends Sections 8-11-1 and 8-11-5 of the Illinois Municipal Code, and

Whereas, said amendments provide that certain described manufacturing machinery and equipment is excluded from the Retailers' Occupation Tax and the Service Occupation Tax, and

Whereas, it is the desire of the City of LeRoy that such machinery and equipment remain subject to said taxes.

Now, therefore, Be It Ordained by the Council of the City of LeRoy, Illinois, as follows:

Section 1. That Chapter 33, Section 33.01 is hereby amended by adding thereto new Section 33.01 (d) to read:

Section 33.01 (d). The exclusion contained in Section 2 (d) of the "Retailers Occupation Tax Act" approved June 28, 1933 as amended shall not apply to property within the City of LeRoy.

Section 2. That Chapter 33, Section 33.02 is hereby amended by adding thereto new Section 33.02 (d) to read:

Section 33.02 (d). The exclusion contained in Section 2 (e) of the "Service Occupation Tax Act" approved July 10, 1961 as amended shall not apply to property within the City of LeRoy.

Section 3. That this ordinance shall be in full force and effect after its passage and approval, and publication, as required by law.
