ORDINANCE NO. 08-03-02-80

**AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF
PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY,
ILLINOIS**

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m., on March 17, 2008 did make and aforesaid determination;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

Section 1. The 1997 Mack Truck, model 600 CH600 with vehicle identification number 1M1AA12YXVW071236, the City Clerk shall place an ad in the Le Roy Journal advertising said personal property for sale and requesting sealed bids be delivered to the City Clerk by 2:00 p.m. on Thursday April 17th, 2008 at which time said bids shall be opened. Final bids will be delivered to the City Council at their regular meeting to be held on Monday, April 21st, 2008 The City Council may reject all bids or may declare the item sold to the highest responsive bidder. The property shall be turned over to the successful bidder upon payment in full of the purchase price.

Section 2. That such sale is hereby ratified effective the date of sale, April 21st, 2008.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


