

**ORDINANCE NO. 08-09-03-80**

**AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF  
PERSONAL PROPERTY OF THE CITY OF LE ROY, MCLEAN COUNTY,  
ILLINOIS**

WHEREAS, The City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

Whereas a majority of corporate authorities now holding office at a regular meeting held at 7:00p.m., on September 15, 2008, did make and aforesaid determination.

Now, Therefore, Be It Ordained, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

SECTION 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
