**ORDINANCE NO. 16-01-03-80**

**AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF  
PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY,  
ILLINOIS**

**WHEREAS**, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

**WHEREAS**, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m., on January 18, 2016, did make and aforesaid determination;

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

**Section 1.** The 2009 Ford Crown Victoria with vehicle identification number 2FAHP71U39X117805, Ray Allen Aluminum K-9 insert, Gambler Johnson dock station for Panasonic mobile data computer serial # 25307AZB021. The Ordinance was amended by council to include retired city street signs as being surplus and therefore available via a request form available at Le Roy City Hall throughout the year for a fee of \$5.00. The City Clerk shall place an ad within local newspaper January 28, 2016 advertising said personal property for sale and requesting sealed bids be delivered to the City Clerk by 2:00 p.m. on Thursday February 11, 2016 at which time said bids shall be opened. Final bids will be delivered to the City Council at their regular meeting to be held on Monday, February 15, 2016. The City Council may reject all bids or may declare the item sold to the highest responsive bidder. The property shall be turned over to the successful bidder upon payment in full of the purchase price. Before offering said vehicle for sale, appropriate city officials shall cause all police equipment, including police lights, siren, cage, and two-way radio to be removed from the vehicle.

**Section 2.** That such sale is hereby ratified effective the date of sale, January 18, 2016.

**Section 3.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


