AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LEROY,

WHEREAS, the City of LeRoy, being a city organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of three-fourths of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said city; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:30 P.M. on March 2 1981, did make the aforesaid determination;

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois:

Section 1. That the 1964 Dodge Dump Truck, Vehicle Identification No. 1581394166, be sold by the City of LeRoy, by notice published in the local newspaper advertising the sale of the property soliciting sealed bids to be received not later than 9:00 A.M., Monday, March 16, 1981, at the City Hall in LeRoy, Illinois, which will be opened at the regular City Council meeting at 7:30 P.M., March 16, 1981.

Section 2. That such sale shall be effective with the highest bid to be awarded the sale of the vehicle. Terms: Cash upon notice of successful bid, cash payment to be made at the City Hall not later than 11:00 A.M., Wednesday, March 18, 1981.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and approval, as required by law.
