AN ORDINANCE AUTHORIZING THE PURCHASE OF EQUIPMENT BY THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS, AN ILLINOIS MUNICIPAL CORPORATION.

Whereas, the Mayor and City Council of the City of LeRoy have determined that the number and extent of sewer lines in the City warrants extensive cleaning and removal of debris from time to time; and

Whereas, the Mayor and City Council of the City of LeRoy have determined that the present equipment owned by the City and utilized for said purposes is inadequate to provide the necessary capability of cleaning sewers and removing debris in a timely manner and in such fashion as to save manpower expenses; and

Whereas, the Mayor and City Council of the City of LeRoy have determined that the purchase of a sewer cleaning machine and root cutting machine would be in the best interests of the City of LeRoy and would save expense in the maintenance of the City sewer system and provide a greater capability for cleaning and maintaining said sewer system in a manner and fashion surpassing the present capability of the City to provide for such maintenance and cleaning services,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. That a sewer cleaning machine and root cutting machine, each as described below, be purchased from the company set forth below for the prices set forth as follows:

(a) Sewer cleaning machine - 1972 Peabody Myers Model 800 Vactor Myers Sherman Company	Sewer Jet, Inc. of Illinois and Missouri	\$32,000.00
(b) Root cutter - Model J 1601 O'Brien 3/4"	Sewer Jet, Inc. of Illinois and Missouri	\$ 1,602.05

Section 2. That the necessary supplemental appropriation ordinance, and ordinances providing for the issuance of tax anticipation warrants or general obligation bonds in an amount sufficient to provide funds as needed by the City to make this purchase promptly be executed this same date, authorizing the Mayor and City Clerk to proceed with the issuance of such warrants or bonds as may be necessary to provide sufficient funds for the purchase of these items of equipment.

Section 3. That the Mayor and City Clerk are hereby authorized to execute such contracts or other documents evidencing the agreement to purchase the aforesaid equipment from Sewer Jet, Inc. of Illinois and Missouri, and that the Mayor is hereby authorized to take such action as is necessary to complete the purchase agreement with said seller and to obtain possession of the equipment on behalf of the City as expeditiously as possible.

Section 4. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
