

ORDINANCE NO. 597

AN ORDINANCE APPROVING FINAL SUBDIVISION PLAT FOR  
LEROY ESTATES SECTION ONE, A SUBDIVISION OF THE CITY OF LEROY, MCLEAN  
COUNTY, ILLINOIS.

WHEREAS, the Mayor and City Council of the City of LeRoy have reviewed the proposed final plat of subdivision for LeRoy Estates Section One, a subdivision of the City of LeRoy, McLean County, Illinois; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that said final plat meets all requirements of the subdivision code of the City of LeRoy, and that the approval of said proposed final plat is in the best interests of the City and its residents,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That the final plat of LeRoy Estates Section One, a subdivision of the City of LeRoy, a copy of which is attached hereto as Exhibit A, and incorporated herein by reference, is hereby approved.

Section 2. The Mayor and City Clerk are hereby directed to execute all necessary documents and certificates as may be appropriate in order to evidence the approval by the City of LeRoy of the aforesaid proposed final plat, and to record said final plat promptly. Upon recording the same the City shall provide copies of said recorded plat as may be appropriate to the developer for record purposes.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication, as required by law.


