AN ORDINANCE REPEALING ORDINANCE NO. 862  
OF THE CITY OF LEROY, MC LEAN COUNTY, ILLINOIS

WHEREAS, the City Council of the City of LeRoy, approved and adopted Ordinance No. 862 on October 18, 1999, and the Mayor of the City of LeRoy did approve the same effective that date; and

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
