

**A RESOLUTION RETIRING A K-9 SERVICE ANIMAL  
PURSUANT TO THE POLICE DOG RETIREMENT ACT**

**WHEREAS**, the Illinois General Assembly has enacted the Police Dog Retirement Act, 510 ILCS 82 et seq.; and

**WHEREAS**, pursuant to the Act, a K-9 service animal that is no longer fit for public service in a municipality must be offered by the municipal police department to the officer who had custody or control of the animal during its service; and

**WHEREAS**, the Mayor and City Council for the City of Le Roy desire to deem K-9 service animal, K9 Peter "Pete" as no longer fit for public service, and Officer Sean Spencer has agreed to take ownership and custody of the service animal upon approval of this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE** Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

**SECTION 1.** The above stated recitals are incorporated herein by reference.

**SECTION 2.** The Mayor and City Council for the City of Le Roy hereby deem and declare K-9 service animal, K9 Peter "Pete" as no longer fit for public service. The City hereby transfers ownership and control of the service animal to Officer Sean Spencer, the service animal's handler during its service, effective upon approval of this Resolution.

**SECTION 3.** This Resolution shall take effect immediately upon its passage and approval as provided by law.
