SUPPLEMENTAL ANNUAL APPROPRIATION ORDINANCE NO. 173  
 FOR THE CITY OF LeROY, ILLINOIS -  
 1982 - 1983

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of said city to purchase radio equipment described as follows:

Motorola Syntor Radio, Serial #T83SRA 3200-K, and components

made available through the auspices of the State of Illinois for use in providing communications services for emergency services providers within the City of LeRoy; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that additional revenues of the city will be made available to purchase said equipment,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. That the ANNUAL APPROPRIATION ORDINANCE NO. 162 FOR THE CITY OF LeROY, ILLINOIS, 1982 - 1983, making appropriations for corporate purposes for the fiscal year beginning May 1, 1982, and ending April 30, 1983, is amended by adding the following under Section 1 General Administration Department, Subsection B "Other",:

"For purchase of radio equipment described as -  
 Motorola Syntor Radio, Serial #T83SRA 3200-K, and components ....\$2,388.50

said appropriation to be received and expended from funds paid to the City of LeRoy under a contract between LeRoy Emergency Ambulance Service, Inc., and the City of LeRoy providing for the purchase of said radio equipment.

Section 2. That the total appropriation under Section 1, B "Other", is hereby amended from \$48,975.00 to \$51,363.50 and that the total appropriation for the General Administration Department is hereby amended from \$69,445.00 to \$71,833.50, and that appropriation for the expenses of the General Administration Department is hereby amended to include a fourth line item of source of revenue, that being as follows:

"Appropriated for the foregoing expenses of the General Administration Department from funds agreed to be paid to City by LeRoy Emergency Ambulance Service, Inc. .... \$2,388.50".

Section 3. That the total appropriation for the City of LeRoy is hereby amended to read:

\$1,000,034,576.05  
 +2,388.50  
 \$1,000,036,964.55.

Section 4. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.

PASSED by the Mayor and City Council of the City of LeRoy, Illinois on the 17th day of January, 1983, and deposited and filed in the office of the City Clerk in said city on that date.
