**ORDINANCE NO. 18-03-03-10**

**AN ORDINANCE RAISING THE  
MINIMUM BID LIMIT AND  
ESTABLISHING A BID WAIVER PROCESS**

**WHEREAS**, the City of Le Roy is an Illinois Municipal Corporation and has authority, pursuant to the Illinois Municipal Code, to enter into contracts for goods, services and public works; and

**WHEREAS**, the Illinois Municipal Code requires that all contracts for the making of any public improvement be awarded after public bidding, where the expense thereof shall exceed the sum of \$25,000; and

**WHEREAS**, the Illinois Municipal Code allows the waiver of public bidding process upon a two-thirds vote of all the Aldermen then holding office (65 ILCS 5/8-9-1); and

**WHEREAS**, the LeRoy City Code, Section 1-9-1, requires public bidding for any public improvements exceeding the sum of \$20,000.00 and does not have a waiver process within said Section; and

**WHEREAS**, it is in the best interests of the health, safety and welfare of the citizens of the City of Le Roy to amend Section 1-9-1 of the LeRoy City Code, to increase the minimum project cost for requiring public bids and providing a bid waiver process in accordance with the provisions of the Illinois Municipal Code.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN FOR THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS**, as follows:

**SECTION 1.** That Section 1-9-1(A) of the City Code for the City of LeRoy is hereby amended to read as follows with strikeouts indicating deletion in text and underscore indicating addition to text.

**A. Bids Required:** All contracts for the making of any public improvement in the city which is not to be paid for in whole or in part by a special assessment or special taxation, and any other work or other public improvement, when the expense thereof shall exceed the sum of twenty-~~five~~ thousand dollars (~~\$20~~25,000.00), shall be let to the lowest responsible and responsive bidder therefor in the manner prescribed herein, and shall be approved by the city council. The City may waive the bidding process by a 2/3rds vote of all Aldermen holding office and enter into a contract without public bidding. (Ord. 14-06-01-50, 6-2-2014)

**SECTION 2. Severability.** In the event any section, clause, provision or part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from invalid parts shall remain in full force and effect.

**SECTION 3. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict hereof, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

**SECTION 4. Publication.** The City Clerk be and she is hereby authorized and directed to publish this Ordinance in pamphlet form, as provided by law.

**SECTION 5. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
