Included on the consent agenda were meeting minutes from March 19, 2018, Special Projects Committee Meeting Minutes from March 19, 2018, invoices from April 2, 2018 in the amount of \$33,197.72 and payroll expenses for the period of March 30, 2018 totaling \$41,151.06.
